EIA has created this document as a guide for students, professionals, and career advisors who are interested in the prospect of employment in the education industry. The goal is to provide information and resources that can both educate interested parties and guide them to opportunities in the industry. Many companies in the education industry offer idealistic goals, combined with competitive salaries and generous benefits. Employment opportunities are as diverse as the companies themselves, ranging from consulting with school operators to working with software and textbook publishers. The industry is in a growth stage, and is expected to be a major component of America's 21<sup>st</sup> Century economy. Numerous new companies will join those currently in the industry to revolutionize the way people learn, research, collaborate, and teach.


Many of the students who graduated during the emergence of the education industry have become its prominent leaders today. Their accomplishments provide a model for the skills and ideals necessary for success. As demonstrated in their careers, the early leaders maintained a simple but potent mindset: improve education by employing sound business management knowledge and high-minded goals. Their impact has set the stage for a new generation to push the envelope of progressive education.

Today's students will become the leaders of tomorrow's education industry. Using a diverse skill set, ranging from business expertise to a deep understanding of education, visionaries have an opportunity to reshape the industry to better serve students of all ages. Individuals seeking a career in the education industry should be passionate advocates of change based on an understanding of the education market today.

## History of the Education Industry

### The Early Players (1990-1998)

During the early years of the education industry, dozens of educator-entrepreneurs sought to transform their skills and knowledge into viable businesses. These years saw the emergence of at-risk services, education management efforts, and the establishment of the Association of Educators in Private Practice (AEPP), the predecessor of the Education Industry Association. The industry became more focused with the arrival of



charter schools, which accelerated the opportunities for private companies to develop offerings to schools.

In the early 1990's, companies began to emerge that provided public schools with alternatives to outsourcing management and operation functions. Two early players, Education Alternatives and Edison Schools, began offering these services despite resistance from teacher's unions and city governments. When Edison announced that each


student would receive a laptop computer, communities began to recognize the power and potential of the providers in the for-profit education market.

Another early bridge for private industry was providing services for at-risk students. Companies such as KIDS1, Options for Youth, Ombudsman Educational Services, Richard Milburn High Schools, and Aspen Education Group created public partnerships and alternative services for students who were unsuccessful in mainstream education. The goal was to provide the at-risk student population, many of whom had serious emotional disturbances and learning disabilities, with the support they needed to become successful students.

By the mid 1990s, the charter school movement began to fuel the expansion of the education industry. Under new legislation, charter schools were better able to contract with private providers and avoid traditional union barriers. Many companies were able to expand their businesses, while new companies entered the market providing special education services to the new schools.

### Age of Transition (1998-Present)

With the gradual expansion of computing power and Internet access, technology drove the industry during the late 1990s. Today, a comprehensive technology framework is beginning to emerge as scores of companies implement new technology platforms geared



specifically toward education. Businesses have responded to important public policy issues relating to standards, assessment, and accountability.

The last decade of the 20<sup>th</sup> Century saw Internet access at the classroom level soar from 3 percent in 1993 to a remarkable 93 percent today. The governmental e-Rate program has been highly successful in wiring schools and classrooms for

connectivity, awarding more than \$2.5 billion dollars annually. Revenues for technology-based education companies have reached the multibillion dollar mark. While sales of technology applications and content outweigh sales of computer hardware and networking equipment, the efficiencies offered from new technology are capturing the attention of administrators, educators, policy makers, and students.

Software companies also began to see remarkable growth in the late 90s. Early companies such as Tom Snyder Productions and The Learning Company began to offer numerous software suites for K-12 classrooms. Software was created to meet specific curriculum goals and provide interactive mediums for improving student performance. Titles such as Oregon Trail and Carmen Sandiego were regarded as models for creating successful “edutainment” software. Other companies, such as Inspiration Software Inc., began to focus resources on productivity tools for students, creating technological aids for visual learning.

At the turn of the century, the Internet became another major channel for educational products and services, although the dot-com boom and subsequent bust took its toll on the emerging industry. According to *Eduventures*, an industry research company, overall investment in education businesses over the past 10 years exceeded \$10 billion. Initially, platform providers emerged with a wealth of resources for children, parents, and educators. Companies in this space, such as Family Education Network, offered a collection of online tools and content-related links for parents, students, and educators. Other organizations, like the now defunct ZapMe! Corporation, were unsuccessful in their attempts to use schools for advertising delivery and marketing research. In total, more than half (\$6 billion) of the money invested was written off by venture capitalists and private equity investors as companies failed because of unproven models and poor due diligence by the investors.

After the Internet bubble burst, investments plummeted, but survivors began to emerge with solid business models. WebCT, DataTel, and Blackboard surfaced, offering complete course management packages, including IT systems for enrollment, assessment, dynamic content, and discussion groups. Today, postsecondary education and technology continue to fuel the growth of the industry. Combining K-12 and postsecondary companies, the industry produces over \$110 billion in revenues with a stock market cap in excess of \$200 billion.

The political environment has also created significant opportunities for education entrepreneurs. In 1998, Congress passed the Children's Online Privacy Protection Act, regulating data mining of children's information under the age of 13 and forcing companies to gain parental consent when collecting this information. In 2001, the No Child Left Behind Act created standards for assessment and accountability that offer more choices to parents and additional flexibility for states and school districts. The Department of Education also set unprecedented goals for technology in education. The National Education Technology Plan has developed objectives to strengthen technology leadership, improve teacher training, nurture e-learning, expand 24/7 broadband access, and move toward digital content.

## ***Future Outlook***

### **The 21<sup>st</sup> Century Education Industry**

Technology-driven growth in education markets and the broader acceptance of for-profit involvement in education have set the stage for an exciting 21<sup>st</sup> Century. The public is more engaged in the issues and is beginning to accept that business has a significant role to play in improving education. Leadership and investment will come from established publishing companies and newly emerging education and technology providers. Though many businesses have already gone public, many more firms are likely to declare IPOs, and conglomerates will spin off their education divisions to the public markets.

Politics will also play a profound role in the education industry's future. In the coming years, the No Child Left Behind Act, Higher Education Act, and Individuals with Disabilities Education Act will reorganize education, creating hundreds of new business opportunities. Summative assessments will become critical to a student's future, leading to a growth in consumer paid education services and preparation materials. Supplemental Education Service Providers, which are companies that provide after-school tutoring, counseling, and test preparation (materials and services), are expected to grow to meet a rising demand. Professional development will be critical for teachers and administrators, who are facing increased expectations and new licensing and certification requirements. Education consultants, management companies, and policy specialists will serve schools at all levels and advise them on their legal, political, and communal obligations.

We are already experiencing a golden age for educational technology. Institutions demand multi-tiered, end-to-end solutions that manage everything from back-office operations to financial aid. Established companies are searching for additional products and services and acquiring new technology companies that can add value to their businesses. Publishers and product manufacturers are extending their technology capabilities, while schools will, in the near future, use wireless technology to bring (portable) computers to every student. Younger and more tech savvy teachers will begin

joining the workforce, bringing an understanding of the power of computers and harnessing technology to create new models of teaching.

The K-16 market is expected to continue its investment in hardware and software and expand the applications available to teachers and students. Just as the business-to-business market has embraced information technology, the education-to-business market will become highly interconnected. Technological aides, similar to AlphaSmart's Dana and Neo, which provide low-cost, high impact products, will become ubiquitous in K-12 schools. The line between education and gaming will blend even further as software companies tune their games to meet specific curriculum goals. Teachers will even be able to use voice recognition packages to track student's phonemic awareness, fluency, grammar, and pronunciation skills.

Higher education will invest in new hardware technologies such as the Tablet PC, while further streamlining their IT infrastructures and embracing "anytime-anywhere" learning. A bright spot in the future of educational technology lies with knowledge webs, collaborative networks, and virtual communities. Online software will simplify collaboration and provide pools of information that are both diverse and subject specific. Web-based resources will expand to search multiple databases and numerous sources, making data on people, places, things, and events available in full-text at the click of a button. Students will manage their classes from portals, using the Internet to interact with each other, keep journals, work in teams, and network with the professional world. Some of the most innovative colleges and universities will even catalog courses on the Web by digitally recording lectures and scanning in class notes.

Exciting times are ahead for students and professionals interested in a career in the education industry. Whether in technology or teaching, management or administration, opportunities abound.

## **Industry Landscape**

### ***Definition of the Industry***

The education industry can be described as the collection of organizations and businesses that provide products and services aimed at enhancing the quality of education in society. The education industry plays an increasingly important role in supporting public education by meeting the demand for products and services that both complement basic education services and supplement their underlying goals. The industry is defined by four main categories: Schools/ Service Providers, Supplemental Education Service Providers, Products, and Education Service Businesses. Each category has distinct market segments, all of which are defined below. For job seekers, having a clear picture of the industry is crucial for researching companies, determining a career path, and exploring potential employers.

## ***Schools / Service Providers***

### **Alternative/Special Education Services**

The alternative/special education segment includes companies that provide services to students with needs that traditional schools cannot meet, providing services to at-risk students, students with special needs, and adjudicated youth. Companies typically operate their own facilities or contract with school districts and juvenile justice departments. In general, the businesses can be totally private, publicly funded by government contracts, or a hybrid between the two models.

The EIA expects the alternative education market to grow substantially. As the student population increases, special education broadens, and government places additional performance and accountability requirements on schools, schools will need additional alternatives to deal with this expanding market. According to the U.S. Department of Justice, about 54 percent of public schools reported taking disciplinary action in the 1999-2000 school years. Of those actions, 11 percent of the students were removed without any service (i.e. expulsions) and only 7 percent were transferred to specialized schools.



## Education Management Organizations

Education management companies are contracted to operate public and private schools. They are responsible for numerous functions, including payroll, meal services, health services, transportation, technology support, and sanitation. While these companies can service any educational institutions, they have found a large market in charter schools, which commonly outsource administrative functions.

The bulk of education management companies focus on charter schools, linking them with the charter school market segment. The politics of this market can be challenging. In particular, many companies walk a fine line when declaring themselves profitable and very few choose to advertise it. Growth in this segment is intimately tied to public support and political reform. Cost cutting measures are likely to be met with vigorous opposition. Negative public perception can have a profound effect on the success and failure of a management company.

## Charter Schools



Charter schools have been a growing phenomenon since 1991. A charter school is a public school that receives government funding, has open admissions, charges no tuition, and is subject to more government regulations. But, unlike traditional public schools, charter schools educate their students based upon the objectives laid forth in their charter. As of April 2005, The Center for Education Reform reported that nearly 3,400 charter schools are

operational, serving approximately one million students. Roughly 10 percent of these schools are operated by for-profit companies.

## Virtual Schools

A virtual school is a fully managed web environment designed specifically for the education sector. Schools and colleges are able to utilize their virtual school to improve open and secure communications between governors, teachers, pupils and parents on both a one-to-one and one-to-many basis, facilitating the development of both e-learning and e-assessment programs.



## Proprietary Schools

While public education has been available since the early 19<sup>th</sup> century, private schools are the oldest educational institutions in the US. Today, families have the advantage of being able to choose between public schools, whose tuition is funded by the state, and private schools, whose tuition is paid out of pocket. Private schools are typically religiously based, though secular and specialty schools exist to a lesser extent. In general, there are



more than 5 million students enrolled in over 27,000 different private schools throughout the country. Since private schools are not run with public money, they are not subject to heavy regulation such as the No Child Left Behind Act.

Private schools are an established market segment in the education industry. As long as there are parents who are dissatisfied with public schools, there will be a market for proprietary schools. For-profit private schools take the form of both franchised businesses and localized companies. Their growth may be supported by the rise of

a successful state and federal voucher program. Vouchers are scholarships awarded to parents in order to fund the tuition expenses of private schools. While vouchers give families additional choice, they are controversial since the money is viewed as being diverted from public education.



## *Supplemental Education Service Providers (SES)*

### Learning Centers

Learning centers are defined as local educational institutions that provide tutoring, test preparation, prescriptive education, and other services outside of the traditional K-16 system. Over the past two decades, this sector has seen significant growth due to societal trends and changes in education.

Learning centers are often considered an alternative to traditional daycare, where working families can extend a student’s school day to coincide with their schedules. Similar to after school clubs and sports, learning centers provide children of all ages with additional experiences, but primarily focus on academic pursuits.



Learning center growth is likely to continue over the next 20 years. The U.S. Department of Labor estimates that more than 60 percent of working women have a child under three

years old. Furthermore, the population of children aged five and under is expected to increase by 3.4 percent over the next two decades. Even in a recent *Newsweek* poll, 42 percent of Americans believe that there is a "great need" for private, outside tutoring. Poor school performance and over-ambitious parents have also led to a surge in demand for extra services. Largely due to these trends, learning center businesses are becoming national brands, where some operate remote divisions and others organize countrywide franchises.

## Tutoring Services

Tutoring services can be offered from private practice educators, learning centers, tutoring franchises, and other education-focused businesses. Tutors can be online, onsite, or in a classroom, as well as one-to-one, one-to-many, and peer-to-peer. Due to new mandates in the No Child Left Behind Act, this market is likely to continue to grow. Students have used tutoring services to brush up on their math and language skills and pass mandatory proficiency tests. Furthermore, Title I of NCLB specifically requires consistently failing schools to offer free tutoring to students from underprivileged families.

In addition, online tutoring has become a growing phenomenon. Online tutoring consists of companies that offer Internet-based study guides, homework support, test preparation, one-on-one coaching, and bilingual services. Tutoring sites connect students with degree-accredited tutors who are knowledgeable in subject specific areas. Companies typically employ various technologies in order to simulate face-to-face communication, including instant messaging, Web conferencing, online white boards, and voice over Internet provider (VOIP). Tutoring companies' customers not only include the K-16 market, but also libraries and learning centers.

Assessment companies contract with schools, school districts, and state governments to fill this growing need. The assessment market is highly sensitive to political legislation, which can directly create opportunities and threats to the companies operating within.

The educational products and publishing sector serves the entire market of public and private schools at all levels of education. The market consists of companies that have products related to the industry (i.e. Apple Computers, IBM, Dell, Xerox, BIC) and others that are focused entirely on education (i.e. Scholastic Incorporated, Houghton Mifflin, Pearson, McGraw Hill).

Publishers in this market are engaged in a mass transition to digital media. Although print sales are still the overwhelming majority in education, the industry is embracing technology by producing complementary CD-ROMs and online resources. Students can find supplemental exercises for their lessons and teachers can find activities and resources to reinforce content. Some companies such as Renaissance Learning have embraced the digital revolution by offering products for K-12 curriculum exclusively on software. These trends are likely to continue as education leaders embrace technology.
